3. 'The Applicant' further understands that 'YCC Poultry' reserves the right to charge interest at the current bank overdraft rate on all overdue monies up to date of payment.
4. 'The Applicant' agrees to pay all expenses, costs and disbursement incurred in recovering any outstanding monies including debt collection, agency fees and legal costs, providing such fees do not exceed the scale charges as charged by such debt collection agencies or solicitors.
5. 'The Applicant' further understands that 'YCC Poultry' reserves the right to withhold the supply of goods and service without notice to 'The Applicant'
6. In the event of this application being successful, a fixed Credit Limit will be determined by 'YCC Poultry'. Should the account balance exceed this limit 'YCC Poultry' reserves the right to withhold supply of good and services without notice to 'The Applicant'.
7. This application gives 'YCC Poultry' the authority to make inquiries as to the credit and financial responsibility of 'The Applicant' and/ or 'Principal(s)' and/ or 'Directors' and obtain reports relating to consumer files from time to time.
8. 'YCC Poultry' and 'The Applicant' purchaser agree that all goods are delivered ex-warehouse. Delivery of the goods to 'The Applicant' purchased, his agent, carrier or representative shall constitute delivery to the purchaser. Probate of the goods passes to the purchaser when the price of the goods has been paid in full. Risk passes to the purchaser upon delivery of the goods to the purchaser.
